TRANSPARENT BILLING

Mediation fees are calculated on an hourly basis, as outlined below:

- 2 Parties: \$225 per party, per hour
- 3/more Parties: \$150 per party, per hour

A "party" is defined as all individuals represented by the same attorney. The hourly rate includes time spent in mediation session, as well as reasonable preparation, review of submissions, communications with counsel, and post-mediation follow-up. Fees are divided equally among the parties unless otherwise agreed in advance.

MINIMUM FEE

- Half-Day Mediation: 3 hour minimum
- Full-Day Mediation: 5 hour minimum

The applicable minimum is billed for any mediation reserved for that time period.

CANCELLATION POLICY

To avoid the minimum fee, notify our office **at least 21 days in advance** if a mediation must be cancelled or rescheduled. To maintain neutrality, the minimum is billed **equally** to all parties, regardless of who cancels or why, even if the case settles or is being rescheduled.

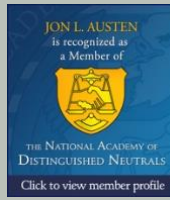
BILLING & PAYMENT

Invoices are issued **after** the mediation (post-billing). Unless otherwise agreed, **counsel are jointly and severally responsible** for timely payment. Payment is due upon receipt and should follow the instructions on the invoice.
